

Mandatory Guidelines for Authors (short version of authors' instructions by BRILL)

The Interdisciplinary "Journal for Religion and Transformation in Contemporary Society" ([JRAT](#)) is an interdisciplinary, international, online open-access journal with a double-blind peer-review process. It was established in 2015 and has been published with BRILL since 2019. Every issue has a distinct thematic focus which is approached from different disciplines. The journal aims at investigating the contribution of religions to the cultural, political, juridical, and aesthetic dynamics in present-day pluralistic societies. Vice versa, it examines the influence of the contemporary processes of social transformation on religions and religious expressions. JRAT is included in SCOPUS and WEB OF SCIENCE.



- Contributions should be grammatically correct and in good literary style. All spelling should be consistent.
- Unless otherwise stated in the Call for Abstracts, the contribution should not exceed 40,000 characters or 6,000 words (footnotes, bibliography and spaces included). If your paper is longer, please contact the special editors.
- **Font:** Times New Roman (12pt.), quotes longer than three lines **indented** (11pt.)
- **Paragraphs:** no blank lines in between paragraphs, each new paragraph starts with an indent, unless after subheadings and after longer, indented citations.
- Please differentiate between **hyphen (-)** and **dash (–)**:
Dash: "from page 50 to page 59" can be replaced by "pp. 50–59"
Dash – like in this example – is also used for parenthesis.
Use hyphenation only for compound words (e.g. well-spoken)
- **Footnotes:** Please use footnotes for all quotations: *short title* in italics in the footnote, full citation in the bibliography.
Citing One Page: Author Name, *Short Title*, p. x.
Citing Two Pages: Author Name, *Short Title*, p. x et seq.
Citing more than two pages: Author Name, *Short Title*, pp. x–y.
If there are several author names, there is no space before and after the slash (/).
Bennholt-Thomsen/Guzzoni, *Analecta Hölderliniana III*, p. 9.
Please don't use "ibid." or "ibid. p. x" but footnotes with short titles only.
- **Citing Websites:** Please use short titles in the footnote and the full citation (incl. URL) in the bibliography.
- **Each article must include a Bibliography:**
 - Please arrange the bibliography alphabetically by author name.
 - Please arrange several titles of the same author chronologically.
 - Please list anthologies from which more than two contributions are cited separately.
 - All bibliographical information closes with a dot.
- **Monograph:** Surname, First Name: *Title*. Subtitle. Place of Publication: Publisher Year.
- **Article in an Anthology:** Surname, First Name: *Title of the Article*, in: First Name Surname (ed.): *Title of the Anthology*. Place of Publication: Publisher Year, pp. x–y.
- **Journal Article:** Surname, First Name: *Title*, in: *Name of the Journal Volume* (Number/Year), pp. x–y.
- **Website:** Surname, First Name: *Title*. Subtitle (if applicable), Date of Publication (if applicable), complete URL (date of last access: DD.MM.YYYY).
- Please submit in addition to your manuscript a duly completed **title page**.
